In honour of Dato' CQ Teo

Dato' CQ Teo was the Founding Chairman of Sri KDU schools. He was widely respected for his visionary leadership, integrity and compassion. Dato' Teo was also a philanthropist had a strong passion for good education as an integral part of nation building. This scholarship was established to continue and honour Dato' Teo's legacy of nation building, in changing lives and enriching communities for a better world.

What is 'The Dato' CQ Teo Scholarship'?

The scholarships are offered to deserving Malaysian students with financial need to provide them the opportunity to develop their potential. The scholarships are highly selective and aim to provide quality education to students who have demonstrated outstanding achievements in contributing to Malaysian society.

For the 2022 intake, we are offering a scholarship for study at:

- Sri KDU Secondary School (entry to Secondary 4)

Sri KDU Secondary School offers programmes of study leading to the SPM (Sijil Pelajaran Malaysia), as laid out by requirements set by the Ministry of Education, Malaysia.

The scholarship covers the 2 years of the SPM programme – Secondary 4 and 5.

What does the Scholarship Committee look for in a potential scholarship candidate?

- Malaysian students from Malaysian curriculum schools aged 16 years old in 2022.
- Household income of below RM120,000 per annum.
- Demonstrates outstanding achievements in contributing to the Malaysian society.
- Strong academic performance.
- Commendable level of oral and written proficiency in English.
- Other considerations include extra-curricular accomplishments, character, creativity and the ability to contribute to the life of the school.

What does the scholarship cover?

Full scholarships cover the following fees:

Sri KDU Secondary School

1. Registration Fee
2. Annual Tuition Fee for Secondary 4 and 5

Note:

1. All other fees (including the refundable Deposit* and examination fee) are to be borne by the student.
2. Scholarships are awarded subject to availability of seats for the class/stream and intake applied.

Important dates to note when applying for the scholarship:

11 October 2021 : The Dato' CQ Teo Scholarship (2022 intake) opens for applications.

5 November 2021 (by 4:00pm) : Last day to submit application for the scholarship. Applications that are incomplete or submitted after 4:00pm (Malaysian time) of 5 November 2021 will not be considered.

Mid-November 2021 : Assessment/Interview stage. **Only candidates who are shortlisted will be notified** by the Scholarship Committee via email (SRIKDU Scholarships@srikdu.edu.my) to continue to the next stage of the application process, which includes an interview. It is compulsory for one parent to be in attendance during the interview.

*Note: If you do not receive an email from us by the **19 November 2021**, it means that you have not been shortlisted.*

2022 : Scholarship commences for the 2022 intake.

How to apply for the scholarship?

1. Application for The Dato' CQ Teo Scholarship is available only online. Click [here](#) to apply.
2. Complete the online application form and upload the following documents:
 - 2.1 Applicant's current photo (passport-sized).
 - 2.2 Applicant's birth certificate and MyKAD.
 - 2.3 Declaration of household income (below RM120,000.00 per annum), together with a certified copy of the latest EA and full B/BE Forms. **The application will not be considered if this requirement is not fulfilled.**
 - 2.4 Description and proof of "Outstanding Achievement in Contributing to the Malaysian Society".
 - 2.5 Letter of recommendation from current school principal.
 - 2.6 Latest semester results.
 - 2.7 Results/proof of outstanding achievements (games, sport or other relevant areas).
 - 2.8 Proof of involvement in school/community activities.

Important Note:

1. Applications that are incomplete or submitted after the deadline will not be considered.
2. Applications must be received online by our office by **4:00pm** (Malaysian time) on **5 November 2021**. Late applications will not be considered.

Terms and Conditions

1. The scholarship recipient ('recipient') may not concurrently hold any other scholarship without the prior written approval of Sri KDU Sdn. Bhd.
2. The scholarship is tenable until SPM (Secondary 5), subject to annual review and renewal.
3. There will be no bond, except that, recipients become active members of the school throughout their studies at Sri KDU Secondary School and leads an impactful community project in honour of Dato' CQ Teo.
4. Refund of Deposit

The Deposit paid is refundable upon full completion of the Secondary 5 programme. If the recipient withdraws prior to completion of the Secondary 5 programme, the Deposit is refundable if a written notice of withdrawal is submitted to the Registry Department at least 6 months before the recipient's last day of school and there is no outstanding amount owed to the school.

5. Grades and achievements of the recipient will be reviewed each year by the Scholarship Committee.

6. For End-of-Year review, recipients are required to submit the following documents to the Registrar's Office at the Main Administration Office (Primary School Block) two (2) weeks before the start of Semester 2 year-end school holidays:
- 6.1 Attendance for the academic year
 - 6.2 Academic and co-curricular performance
 - 6.3 Brief write-up and documentary proof of leading an impactful community project
 - 6.4 Performance in relevant area/exceptional achievement
 - 6.5 Brief testimonial from the Homeroom Teacher on conduct and behaviour at school, during co-curricular activities, etc.
 - 6.6 A certified copy of each working parent's:
 - 6.6.1 latest filed B/BE form; and
 - 6.6.2 last 6 months' payslip.

The Scholarship Committee reserves the right to revoke the scholarship at any time if this clause (clause no. 6 and its sub-clauses) is not complied with.

- 7. In Secondary 5, the recipient writes an editorial piece for the school yearbook titled "A tribute to Dato' CQ Teo", describing the impact receiving this scholarship has on the recipient in the 2 years at Sri KDU.
- 8. Sri KDU Sdn. Bhd. reserves the right to revoke the scholarship at any time if the recipient's conduct and/or actions bring disrepute to Sri KDU Sdn. Bhd. and/or any of its schools.
- 9. All decisions pertaining to the scholarship rests with the Chief Executive Officer of Sri KDU Sdn. Bhd. and are final.
