What is the International Baccalaureate Diploma Programme Scholarship?

Each year, Sri KDU Sdn Bhd offers a limited number of competitive scholarships for the International Baccalaureate Diploma Programme (IBDP) at Sri KDU International School.

The IBDP is a demanding pre-university course of study that gives holders access to the world's leading universities. It is a comprehensive two-year international curriculum. Students of the programme share an academic experience that emphasizes critical thinking, intercultural understanding and exposure to a variety of points of view.

Sri KDU International School is an authorised school (IB World School) of the International Baccalaureate Organisation that offers the IBDP at its school campus in Kota Damansara, Selangor Darul Ehsan, Malaysia.

Sri KDU International School aims to bring international education to highly motivated students who are able to demonstrate a strong commitment to learning. The IBDP Scholarship is offered to deserving students aged 16 – 19 years, to provide them the opportunity to develop their potential.

Students are accepted into the IBDP at Sri KDU International School in September each year.

Who is eligible to apply for the IBDP Scholarship?

The scholarship award is based on academic and extra-curricular merit and is very competitive.

The selection system is criterion-referenced, and candidates must demonstrate a high level of oral and written proficiency in English.

Outstanding students who are completing the IGCSE, SPM and equivalent high school qualifications are invited to apply for the Sri KDU International School IBDP Scholarship.

What does the IBDP Scholarship cover?

- The scholarship award is tenable for the two-year period of candidature of the IBDP.
- Awards are made for a single year. Recipients will qualify for renewal for the second year when they make satisfactory progress toward completion of the programme.
- The scholarship covers the following fees:
 - ✓ Registration Fee
 - ✓ Annual Tuition Fees

Note:

All other fees (including the refundable Deposit* and examination fee) are to be borne by the student.

Important dates to note when applying for the IBDP Scholarship

29 October 2019 : The IBDP Scholarship opens for applications.

29 November 2019 : Last day to submit application for the scholarship. Applications that are incomplete, or
(by 4:00pm) submitted after 4:00pm (Malaysian time) of 29 November 2019 will not be considered.

December 2019 : Only candidates who are shortlisted will be notified by the Sri KDU IBDP Scholarship Committee via email (IBDPscholarships@srikdu.edu.my) to continue the next stage of the application process.

September 2020 : Scholarship commences for the September 2020 intake.

How to apply for the IBDP Scholarship?

1. Application for the IBDP Scholarship is available only online at <https://bit.ly/2MKdy2b>.
2. Complete the online IBDP Scholarship Application Form and upload the following supporting documents:
 - 2.1 Applicant's current photo (passport-sized).
 - 2.2 Applicant's MyKAD/Passport (page on particulars only).
 - 2.3 A type-written copy of your Personal Statement. Include your involvement in community and social projects, in not more than 300 words.
 - 2.4 Letter of recommendation from current school principal (not a requirement for applicants who are current students from Sri KDU International School).
 - 2.5 Latest semester results (school reports/transcripts – SPM, IGCSE or equivalent).
 - 2.6 Results/proof of outstanding achievements (games, sport or other relevant areas).
 - 2.7 Proof of involvement in school/community activities.

Important Note:

1. Applications that are incomplete or submitted after the deadline will not be considered.
2. Applications must be RECEIVED online by our office by **4:00pm** (Malaysian time) on **29 November 2019**. Late applications will not be considered.

Terms and Conditions of the IBDP Scholarship

Definition of terms used:

IBDP – International Baccalaureate Diploma Programme

Scholarship – IBDP Scholarship administered by Sri KDU Sdn. Bhd.

Recipient – IBDP Scholarship Recipient

School – Sri KDU International School

1. The IBDP Scholarship for the September 2020 intake amounting to **RM128,400.00** (Ringgit Malaysia One Hundred Twenty Eight Thousand Four Hundred Only) shall cover the following fees, provided the Recipient completes the full two-year programme of the IBDP:
 - 1.1 Registration Fee of RM1,200.00 (Ringgit Malaysia One Thousand Two Hundred Only); and
 - 1.2 Tuition Fee of RM127,200.00 (Ringgit Malaysia One Hundred Twenty Seven Thousand Two Hundred Only) for the two-year programme.
2. Upon accepting the Scholarship offer, the refundable deposit of RM7,800.00 (Ringgit Malaysia Seven Thousand Eight Hundred Only) shall be paid in full by the Recipient. This deposit is refundable upon the Recipient's full completion of the IBDP in July 2022, subject to the terms and conditions of the latest Sri KDU International School (Secondary & International Baccalaureate Diploma Programme) Handbook and Notice of Fees.
3. If the Recipient intends to withdraw prior to completion of the IBDP, the following conditions shall apply:
 - 3.1 A written notice* of withdrawal must be received by the **Registry Department** at least 3 months before the Recipient's last day of school.
 - 3.1.1 Provisional or conditional notice of withdrawal is not accepted.
 - 3.1.2 The notice of withdrawal must be delivered by hand or sent by AR Registered Post or by email (sent to registry@srikdu.edu.my) to the Registry Department at the Main Administration Office at the address/email address set out in this document or any other address/email address, which may be applicable from time to time. The Recipient/parent/legal guardian must ensure that the receipt of the notice of withdrawal is duly acknowledged by the Registry Department.

**notice of withdrawal should be made in writing and signed by the Recipient's parent/legal guardian if the Recipient is below 18 years old upon submitting the notice of withdrawal, unless otherwise agreed in writing by both parents/legal guardians or by court order instructing the same and shall set out the date and reason of the withdrawal.*

- 3.2 The following liquidated damages must be fully paid by the due date set by Sri KDU Sdn. Bhd.:
- 3.2.1 Pro-rated Tuition Fee for the 'period enrolled' in the IBDP. The Tuition Fee for the 'period enrolled' shall be paid in full regardless of whether the Recipient is physically present at the School.
- (‘Period enrolled’ refers to the duration from the first day of school of the Year 12 programme until the Recipient’s last day of school or until the last day of the 3 months’ withdrawal notice period, whichever is later.)

If clauses 3.1, 3.2 and their respective sub-clauses are met and there are no outstanding amounts owed by the Recipient to the School, the deposit will be refunded.

- 3.3 All monies refundable under the scholarship document herein shall be refunded free of interest and will be issued in cheque within two (2) months from the Recipient’s official last day of school provided that all the terms and conditions pertaining to the refund have been complied with.
- 3.4 All withdrawals are subject to an administrative charge of RM200.00 or the prevailing amount at the time the notice of withdrawal is received by the Registry Department.
4. The IBDP Examination Fee shall be paid in full by the Recipient upon registration of examination subjects. The amount to be paid and its due date shall be advised by the Bursary Department of Sri KDU Sdn. Bhd.
5. The Scholarship is tenable for the two-year period of candidature of the IBDP. The award is made for a single academic year and the Recipient will qualify for renewal for the second academic year when satisfactory progress (minimum 5 points for every subject taken) is made.
6. For the End-of-Year review by the Scholarship Committee, the Recipient shall be responsible for the submission of the following documents to the Registrar’s Office at the Main Administration Office (Primary School Block) two (2) weeks before the end of Term 3:
- 6.1 Attendance for the academic year
- 6.2 Academic and co-curricular performance
- 6.3 Performance in relevant area/exceptional achievement
- 6.4 Brief testimonial from the Classroom Tutor on conduct and behaviour at school, during co-curricular activities, etc.
- Sri KDU Sdn. Bhd. reserves the right to revoke the Scholarship at any time if this clause (clause no. 6 and its sub-clauses) is not complied with.
7. The Recipient of the IBDP Scholarship may not concurrently hold any other scholarship/grant without the prior written approval of Sri KDU Sdn. Bhd.
8. There is no bond under this scholarship, except that the Recipient becomes:
- 8.1 an active student ambassador of Sri KDU International School throughout the two years of the IBDP; and
- 8.2 an active member of the Sri KDU Alumni Association upon completion of the IBDP.
9. Sri KDU Sdn. Bhd. reserves the right to revoke the Scholarship at any time if the Recipient’s conduct and/or actions bring disrepute to Sri KDU Sdn. Bhd. and/or any of its schools.
10. All decisions pertaining to the Scholarship rests with the Chief Executive Officer of Sri KDU Sdn. Bhd. and are final.
